NICKI DE NEPHEW tracked the pacesetter while saving ground, bid two wide midway on the far turn, kicked clear in upper stretch and held well under urging. FEDERAL DOMINANCE stalked outside, chased three wide on the far turn and rallied for second. BIGMOUTHED raced off the pace inside, chased inside on the far turn and rallied mildly inside for third. NO MO PROMISES raced two wide off the pace, chased between rivals on the far turn and lacked a rally. FOREST PARK raced off the pace outside a rival, went three wide on the backside, four wide past the quarter pole and lacked a rally. CHANGE OF VENUE raced off the pace inside and did not factor. JAMES CIRO set the pace on the inside, dueled with the winner on the far turn and faded in the final furlong.
