## Footnotes

FRANK FIRST bumped with KID DRAMA shortly after the start, moved up to challenge SCAR from outside after five furlongs, battled through a long drive and prevailed while drifting out. SCAR got the best of a pace dispute with ST JOE VIPER midway on the turn, got tackled immediately after that by FRANK FIRST, drifted out clinging to a tenuous lead past the eighth-pole, and yielded grudgingly. KID DRAMA bumped with FRANK FIRST soon after the start, moved up around the turn four wide, but flattened out in the stretch. BACANO bumped with MR. CESCO coming out of the chute, got through on the rail inside a tiring ST JOE VIPER coming to the quarter-pole, but was empty. VIOLENT FIGHT raced three wide, and tired before reaching the stretch. ST JOE VIPER dueled inside SCAR for a half-mile, and gave way around the turn. MR. CESCO bumped with BACANO trying to make some room for himself entering the main track, got steadied and shuffled back in a crowd soon after completing a quarter-mile, stopped on the turn and was eased up in the stretch. This race was hand timed.
