## **Footnotes**

RENAISANCE FROLIC stalked along the inside, shifted outside of the leader entering the lane while outkicking outer foes, bid outside of the pace setter at the furlong grounds, and drew off. SAND DANCER trailed along the inside, awaited racing room behind FOREVER MO in upper stretch, found a hole inside the final furlong, and surged between rivals to outfinish the aforementioned foe for place. FOREVER MO lied off of the pace along the inside, shifted to the the two path turning for home, then to the three path in midstretch to produce a late kick, but was outfinished by an inner surging rival for place. UNMOORED set the pace along the inside, scooted away from pressing foes turning for home with RENAISANCE FROLIC in pursuit, but was headed by that foe passing the furlong pole, and tired. MO MAVERICK tracked from midpack two wide, advanced to a three wide stalking position into the far turn, produced a mild bid turning for home, but was outkicked by an inner foe shortly after, chased that rival through the lane, but faded late. IDENTIFIER lied off of the pace in the two to three paths around the turns, and failed to factor. GEMONTEER achieved stalking position while shifting from the three path to the two path around the first turn, held that stand through the far turn, but was outkicked by an inner rival turning for home, and weakened in upper stretch.
