ANNEX settled off the pace two wide, angled seven wide turning for home, rallied on the left lead, switched leads near the sixteenth pole and was up late under left-handed urging. SCARLETT SKY saved ground off the pace, split rivals two wide near the eighth pole, took the lead soon after, battled on inside of the winner and just missed. CHESS'S DREAM was unhurried while saving ground early, advanced four wide around the far turn and rallied through the lane to gain the show late. FIGHTING FORCE settled off the runaway pace two wide, bid between foes nearing the eighth pole but was outfinished. SIGILOSO raced off the pace three wide, bid between rivals nearing the eighth pole but was outkicked through the final furlong. CAVE HILL trailed two and three wide to upper stretch, swung widest and passed tiring rivals. HOT BLOODED chased the runaway pacesetter from the rail in the clear, took the lead nearing the eighth pole but wilted soon after. ARZAK ran off to set a sizzling pace and stopped in the drive. THE RUN-UP WAS UNAVAILABLE.
