VANZZY angled over into the first turn, was blocked on the final turn, split foes, into the stretch and gamely prevailed between opponents. ANGELUS WARRIOR taken up into the first turn, saved ground, angled wide on the final turn, battled the winner but was outfinished. ALWAYSMINING prompted the pace outside, earned a brief lead into the stretch and continued willingly. SHANE'S JEWEL broke alertly and led inside to the stretch and weakened. ASPECT trailed inside, moved wider in the stretch closing the gap while no threat. SAND DANCER dropped back early and lacked a solid rally. HONOR THE FLEET prompted the pace outside then gave way. SARATOGA JACK broke very poorly, rushed wide to contention then stopped. A claim of foul by the trainer of the runner-up against the winner for interference into the first turn was dismissed.
