MY PHILLY TWIRL was forwardly placed just off the leader in opening stages, got carried out three wide around the first turn, stalked SURREAL FANTASY up the backstretch, made a bid near the quarter pole, vied for the lead outside of SOUL OF AN ANGEL near the furlong marker then took command, stayed on gamely and held firm. LOVE HER LOTS settled nicely while rated just off the early pace, given cue four to five wide entering the lane, sustained a steady bid under strong left-handed pressure, edged closer and captured place. ON ALERT was allowed to settle in the back although never far from the frontend, picked up the pace three wide around the far turn, launched a two wide bid into the upper stretch, inched way up closer and narrowly missed place. SOUL OF AN ANGEL secured inside position around the first turn and tracked the top two leaders up the backstretch, picked up the pace along the rail around the far turn, came off the inside and took over the lead at the head of the lane, fought back inside eventual winner into the final furlong then weakened in deep stretch. SURREAL FANTASY sped to the lead at the start, drifted out three to four wide around the first turn, set the pace near the inside up the backstretch, began to lug out late on the far turn, came under a firm hold to edge back and move out, dropped to last, launched a five wide re-bid but needed more for impact. KITTEN'S COLLUSION settled three wide not far off the early pace, was ridden along the inside around the far turn, sustained bid into the upper stretch then weakened. RUN UP UNAVAILABLE
