VAL'S GAL checked trying to the avoid the fallen rider soon after the start, sped to the front once clear, set the pace in the two path, drew off around turn, widened in upper stretch, drifted out a bit late and held safe under moderate urging. MAJOR PRYCE raced off the pace three wide, swung widest in upper stretch and surged through the final furlong. LILY OF WICKLOW broke awkwardly, chased the winner three wide and held well enough for the show. ANNA'S IMAGE went evenly inside. MARVELOUS LADY played no factor while racing two wide. SHILOH was outrun while racing four wide. MOVE TO ORDER was hampered trying to avoid the fallen rider soon after the start and was always far back. RIPLEY was reluctant to load, broke on top but stumbled and unseated the rider soon after the start and walked off. THE STEWARDS CONDUCTED AN INQUIRY INTO THE INCIDENT SOON AFTER THE START AND FOUND NO REASON TO ALTER THE ORIGINAL ORDER OF FINISH.
