DEAN DELIVERS bobbed at the break, pressed the pace between foes in the three path, was under a drive around the turn, put a head in front in upper stretch then drew off readily through the final furlong. AVANT GLORY set the pace in the two path, yielded to the winner in upper stretch but kept on to be a clear second. GRAINGER COUNTY stalked the pace four wide, had aim near the quarter pole but lacked a closing bid. JOE DI BAGGIO chase the pace in the two path and lacked the needed rally. AGARRAMESIPUEDES was outrun inside. TRINNI SUMMER had his head turned at the start, raced in range five wide and wilted in the lane.
