Footnotes

ATOMICALLY settled off the early pace while racing five wide around the first turn, advanced outside down the backstretch, bid three wide into the far turn, seized command near the seven-sixteenths marker, quickly cleared, angled in nearing the lane and drew off under a drive. LYNX settled off the early pace while racing two wide, edged closer between foes down the backstretch, angled out nearing the far turn, advanced five around the far turn, angled into the three path nearing the quarter pole, had aim outside of the winner but was clearly second best in the lane. DORTH VADER was up close inside, steadied near the half-mile pole, split rivals three wide midway around the far turn, was no match for the top two but stayed to easily best the best. TIME PASSAGE stalked the pace three and four wide and came up empty in the lane. SHERLYN GO GO failed to menace while racing two and three wide. DREAMING IN STYLE set the pace off the rail around the first turn, dueled inside down the backstretch and faltered around the far turn. MARVELOUS LADY was reluctant to load, was bumped at the start, raced off the pace four and five wide, had no response and was eased through the lane. HIGH FASHION LADY bobbed at the break, saved ground and made little impact. CAJUN TEASE stumbled at the start then bumped MARVELOUS LADY, advanced four and five wide around the first turn, dueled outside down the backstretch, stopped midway around the far turn and was eased in the drive. GUARDIAN ANGEL bobbed at the break, chased the pace three wide, was through early and was eased.
