Footnotes

GENERAL ROBINSON led the way while saving ground around the first turn and up the backstretch, raced in the two path around the far bend and drew off in the lane. BANK BUSTER saved ground early, chased the leader on the inside up the backstretch, offered a bid from the two path coming around the second turn, could not go with the winner in the stretch and kept on to the finish. CAYMAN QUEEN raced in the two path around the first turn, settled off the pace on the outside for the run up the backstretch, navigated the far turn from the three path and gained ground in late stretch. DUDEFOOLINGDARLING saved ground around the first turn, raced off the pace on the inside up the backstretch, came around the far turn in the three path and improved position late. MARVELOUS LADY raced in the two path around the first turn, tracked the leader on the inside up the backstretch, saved ground around the second bend, raced into mild traffic in upper stretch and flattened out from there. WICKLOW GAL saved ground at the back of the pack through the opening half mile, moved up on the field while racing in the five path around the far turn and never threatened. WIFEY MATERIAL saved ground around the first turn, continued up the backstretch in the middle of the pack on the inside, saved ground around the second turn and faded in the lane. VALIANT MISTRESS raced in the three path around the first turn, stalked the leader on the outside up the backstretch, navigated the far turn from the four path and tired in the stretch. THE RIDER OF HORSE SEVEN, MARVELOUS LADY, FILED AN OBJECTION CITING INTERFERENCE FROM HORSE SIX, BANK BUSTER AT THE TOP OF THE STRETCH. UPON REVIEW, NO CHANGES WERE MADE TO THE ORDER OF FINISH.
