STAKES Honey Ryder S. Black Type - Thoroughbred

FILLIES, THREE YEARS OLD. Free nomination by Sunday, April 23. \$750 to enter. \$75,000 Guaranteed. A \$100 supplemental nomination fee may be made prior to closing time of entries. After payment of 1% to all owners of horses finishing sixth through last, 60% of the remaining purse shall be paid to the owner of the winner, 22% to second, 10% to third, 5% to fourth, and 3% to fifth.

*(Not part of the announced gross purse, the FTBOA offers \$25,000 to the owner of a registered Florida-bred finishing first, paid directly by FTBOA). Weight: 123 lbs. Non-winners of a stakes on turf allowed 3 lbs.; a race other than maiden, claiming, starter or state-bred allowance, 5 lbs. Starters to be named by usual time of closing. All fees shall be paid prior to the start of the race.

Preference will be given to stakes winners, stakes placed then by highest career earnings. In the event this race is taken off the turf it will be run on the Tapeta course at a distance of One Mile and Seventy Yards. (If deemed inadvisable to run this race over the turf course, it will be run on the Tapeta Course at One Mile and Seventy Yards) (Rail at 63 feet).

Footnotes

HONOR D LADY was brushed by an inner foe just after the start, stalked in the four path, was ridden around the far turn and fanned out to the seven path into the stretch, stayed on to bid while being herded out into the final furlong, and drew past a pair of inner foes in the final sixteenth to win. OCEAN CLUB brushed with an outer foe just after the start, raced up close while under a hold in the three path, bid early around the far turn, floated out to the six path into the lane, ran on to sustain that bid while drifting into the final furlong, but was outfinished by an outer foe to place. VIOLET GIBSON (IRE) rated in the three path, was driven around the far turn and in the five path at the top of the stretch, kept on while tipping inwards, and was up for show. TIME PASSAGE set the pace inside, was challenged by an outer foe and roused from the two path around the far turn, tipped out to the four path into the lane, drifted out while clinging to the lead passing the eighth pole, but yielded late. LADY AZTECA had her head turned and was brushed by an inner foe at the start, moved up along the rail around the first turn and tracked in the two path down the backside, was under right handed urging from the rail around the far turn, but flattened from around the three path in the stretch. SHERLYN GO GO brushed with foes on both sides after the start, travelled in range between foes in the three path, but was empty in the two path entering the stretch. SHE'S A JOY brushed an outer foe at the start and was always behind around the five path.
