XY TIME set a rated pace inside and held firm under a drive. MANNIX (IRE) stalked the pace between foes, angled to the rail entering the far turn, tipped back out near the quarter pole, had aim outside of the winner throughout the stretch run but was held at bay. THE SLEEPYCHIPMUNK raced in range two wide, bid three deep rounding the far turn, continued on the left lead in the lane, lacked the needed rally and held well enough for the show. EUPHORIA STAR raced off the pace two and three wide, swung six wide in upper stretch and never threatened. SWIFT KID saved ground off the pace, swung five wide in upper stretch and was no menace. T VILLE prompted the pace three wide and tired in the drive. SUN VIKING stalked the pace from the rail, was shuffled back entering the far turn and had no further bids. AN OBJECTION LODGED BY THE RIDER OF SUN VIKING AGAINST MANNIX FOR ALLEGED INTERFERENCE ENTERING THE FAR TURN WAS NOT ALLOWED.
