KANTHARI set a pressured pace in the two path and edged clear under a drive. CAROTARI pressed the winner in the three path, could not get past but held safe for the place. RUN CURTIS RUN was off slowly, trailed three wide, angled widest in upper stretch and rallied outside while trying to lug in through the stretch. AXTHELM raced well back three wide, angled five wide in upper stretch and rallied while racing in tight quarters between foes. OXYMORE chased the pace two and three wide and was one-paced through the lane. CRISPY CAT (GB) raced off the duel in the clear in the two path and weakened in the stretch. BOHEMIAN BOY played no factor while racing two wide. AVANT GLORY was outrun inside.
