E M'S TREASUREGIRL trailed inside, tipped two wide near the quarter pole, rallied between foes, took the lead near the sixteenth pole but was outkicked late. LUCKY GIRL COCO set the pace inside, drifted out a bit in upper stretch, led to the sixteenth pole and held third. MY ROYAL VOW raced in range three and four wide and was one-paced through the lane. HOUSE OF MELODY saved ground in range and lacked a closing bid. LADY AZTECA failed to menace while racing two and three wide. I'M BLUSHING settled off the early pace two wide, bid three wide between foes around the far turn then was blocked for most of the stretch run. BELLESHAZZA prompted the pace two wide and weakened through the lane.
