CATALINA CREE squeezed early, angled three wide upper, bid mid-stretch, driving. EXCUSES tracked between, swung five wide upper, closed fast, up place. PROTEST pressed two wide, vied mid-stretch, outfinished, tagged for place. MCMULLEN showed speed, contested pace inside to stretch, faded late. HOORAY FOR ME tracked outside, chased four wide upper, weakened final furlong. KANTHAROS JR in tight, checked into turn, angled out upper stretch, no rally. MY RIGHT HAND chased inside, in tight, checked into turn, no final response. THE STEWARDS CONDUCTED AN INQUIRY INTO THE ACTIONS OF EXCUSES AND KANTHAROS JR ALONG THE FAR TURN. IN ADDITION THE RIDER OF KANTHAROS JR LODGED AN OBJECTION AGAINST THE RIDER OF EXCUSES, CLAIMING INTERFERENCE ON THE TURN. THERE WAS ALSO AN OBJECTION LODGED BY THE RIDER OF MY RIGHT HAND AGAINST THE RIDER OF CATALINA CREE, CLAIMING INTERFERENCE AT THE STEWARDS DISALLOWED THE OBJECTIONS AND RULED THERE WOULD BE NO CHANGE.
