IRIDEO (ARG) settled while never far back, bid two to three wide and between foes into upper stretch, responded into the final sixteenth and surged for the

win in the final strides. SAMBURU (GB) settled, advanced four wide to stretch, battled IRIDEO (ARG) to deep stretch, was bested late and got up for the place. QUEREME PASS (ARG) set pace to stretch, held a clear lead past mid-stretch, all out late, was overtaken in the final strides and just held for third. BATTLE CALL unhurried, swung six wide upper, finished well, missed third. OISHI step slow start, asked five wide upper, best stride late. FREGON settled inside, traffic upper stretch, gaining late. POSITIVE REVIEW stalked two wide to second turn, chased stretch, no final kick. SPEED RUNNER settled, angled three wide upper, in tight mid-stretch, no rally. TICKING well placed inside, tracked to second turn, weakened stretch. PEACE NOT WAR tracked three wide to second turn, gave way stretch.
